AND BE IT FURTHER RESOLVED, that the Board of Education hereby awards the three transportation contracts set forth above to Quality Bus Service, LLC. for a term of five years, from the 2017-18 through 2021-22, subject, however, to the approval of the District's voters at the Annual Meeting on May 16, 2017;

AND BE IT FURTHER RESOLVED, that in the event that the District's voters do not approve the multi-year contracts for transportation, the Board hereby awards the transportation contracts for a one-year term, subject to renewal for additional years, in accordance with the Regulations of the Commissioner of Education;

AND BE IT FURTHER RESOLVED, that the Board of Education hereby authorizes the Board of Education President and/or Superintendent of Schools, as appropriate, to execute contracts with Quality Bus Service, LLC. for the home-to-school transportation, field and Athletic Trips Transportation, and summer school transportation, upon submission by Quality Bus Service, LLC. of the required insurance certificates in the amount and the form indicated in the proposal specifications.
